Decisions made with community input are essential to successful natural resource management. As a community organisation, Terrain NRM welcomes the community's participation in all its activities. The Terrain NRM Membership body was established to provide a direct link between the community and the Board of Terrain NRM.

Ordinary Membership is open to any not for profit organisation with a bona-fide interest in natural resources in the Wet Tropics. Voting at General and Annual General Meetings is restricted to Ordinary Members via a nominated Delegate.

Completed applications for Ordinary Membership will be considered by the Board of Terrain NRM.
