

# Expression of Interest Green Connections Revegetation/Restoration Projects

Terrain NRM is seeking Expressions of Interest (EOI) from stakeholders interested in funding for revegetation or restoration under the new Green Connections project.

The project runs from now until June 2028 and aims to deliver the following:

- Revegetation (i.e., planting seedlings):
  - 9 ha of any native vegetation community, and
  - 2 ha of Threatened Ecological Community\*
- Restoration (i.e., assisted natural regeneration and weed/pest control):
  - 44 ha in any native vegetation community, and
  - 20 ha in a Threatened Ecological Community \*

## What we are looking for

EOIs are invited from stakeholders with revegetation or restoration proposals located within or close to:

- **Ecological Corridors Wet Tropics World Heritage Area\***
- **Strategic Rehabilitation Areas\*.**

**NB** Other areas may also be considered.

## Eligible activities include:

- Revegetation
- Assisted natural regeneration
- Weed control
- Pest animal control

### **Additional considerations:**

- Works should be on private land.
- Revegetation should be timed for planting **within the next 18 months**.
- Maintenance of plantings should be included.
- **2026 planting proposals** should outline where trees will be sourced from and confirm appropriate species availability.
